Do enter incidents relating to refusal of service in a log book, especially those involving threats or aggression. Don'ts of service refusal. A CDL will be disqualified for one year for a chemical test refusal or failure, OUI (operating under the influence), an OUI in a CMV, leaving the scene of an accident, or using a motor vehicle in the commission of a felony. The disqualification will be for three years if the violation occurred in a CMV carrying hazardous materials.
