To obtain an FSC, you must score at least 75% on an objective written test pertaining to firearms laws and safety requirements. The test is administered by DOJ Certified Instructors, who are generally located at firearms dealerships. An FSC is valid for five years. The fee for taking the FSC test and being issued an FSC is twenty-five dollars (\$25). Firearms being returned to their owners, such as pawn returns, are exempt from this requirement.

Upon passing the exam: You must have a minimum of 70% in order to pass. When you pass, your certification card will be mailed to you within two weeks from the date of your exam. If you fail the exam: You must retake the exam by completing the Retest application form. There is a 60 day waiting period from the date you failed.
