Examples of effective purpose statements: (1) "This paper will describe four common causes of co-worker conflict in organizations and explain how to use a five-step procedure to constructively manage this conflict." Critique: Very specific about what aspects of conflict will be discussed. Very precise about how much information will be given.

For example, is an educated bureaucrat writing with third-hand knowledge of rural hunger riots? Where, why, and under what circumstances did the author write the document? How might the circumstances (e.g., fear of

censorship, the desire to curry favor or evade blame) have influenced the content, style, or tone of the document?
