Under the provisions of the International Registration Plan (IRP) and the International Fuel Tax Agreement (IFTA), South Carolina is required to conduct audits on motor carriers that claim this state as their base to ensure compliance with the terms of the IFTA Audit Manual and the IRP Audit Procedures Manual.

Audits. The District of Columbia is required to conduct periodic audits of IRP vehicles to verify compliance with the Plan. Operational records must be made available at the owner's registered place of business, or be delivered in person or by mail to the DMV's IRP office as directed. Audit results are sent to the carrier, and to all IRP jurisdictions for which a carrier is registered.
